Key Requirements:

- This position requires a Public Trust background investigation.
- You must be a U.S. citizen or National to be considered for this position.
- This position is 100% travel, and you will be required to travel up to, but not limited to 320+ days a year. When not deployed, your duty station will be your residence of record (ROR).
- Preference is that you have completed a BA or Master's degree program in related subject.
- You must be able to obtain and maintain a Government credit card.

Special Physical Requirements:

- Work is performed at a desk, walking, standing, bending, carrying light to medium objects, and in austere conditions.
- You must be able to walk, stand, and sit, for extended periods.
- You must be able to work in austere conditions and in undesirable locations.
- Work may take place in undesirable conditions that include exposure to excessive heat, unhealthy environments, and extended hours.
- You must be able to stay in temporary housing when deployed if necessary.
- Housing accommodations may be limited and require stays in temporary structures without electricity.

Duties:

- Review and implement Executive Orders 11988: Floodplains and 11990: Wetlands (though the 8-step review process); all
 applicable environmental and historic preservation laws, regulations, additional executive orders, and policy for FEMA
 funded activities.
- Prepares National Environmental Policy Act (NEPA) documents based on the applicable level of review.



- Serves as a technical specialist on floodplains and wetlands, providing advice and assistance to FEMA program staff, state
 emergency management staff, Tribal, state, local governments, and eligible private non-profit groups.
- Performs technical project monitoring and evaluations to meet environmental and historic preservation responsibilities.
- Analyze and apply a wide range of scientific and technical to environmental compliance review; specifically Executive Orders 11988: Floodplains and 11990: Wetlands.

Your resume must show that you meet requirements for this position. You may be found "not qualified" if you do not possess minimum competencies required for the position. To accurately credit your experience, please make sure to list the dates (from MM/DD/YY to MM/DD/YY), along with the job title and specific duties you were responsible for during each deployment and/or employment.

To qualify for this position at the IC-11 (\$62,236.00) level, your resume must demonstrate at least one full year of specialized experience equivalent to the IC-09 level in federal service. This experience may have been gained in the federal government, a state or local government, a non-profit organization, the private sector, or as a volunteer; however, your resume must clearly describe at least one year of the following specialized experience:

- 1. Reviewing projects or programs to ensure compliance with environmental laws (i.e., the Endangered Species Act, National Historic Preservation Act, Clean Water Act, Clean Air Act, Coastal Barrier Resources Act, National Environmental Policy Act, Fish and Wildlife Coordination Act and Executive Orders 11988 (Floodplains), 11990 (Wetlands), and 12898 (Environmental Justice)
- 2. Developing environmental documentation, reports, or plans, and
- 3. Conveying environmental policy and program concepts to stakeholders
- 4. Reviewing and making technical comments on environmental documentation prepared by stakeholders
- 5. Evaluating the impact of environmental projects

Other Information:

- All candidates must be able to deploy with little or no notice to anywhere in the United States and its territories for
 an extended period of time. Deployments may include working more than eight hours a day, or more than 40 hours
 in a given week, including weekends and holidays, and under stressful, physically demanding, and austere
 conditions. When activated and deployed, you serve in a federal travel status and are entitled to lodging,
 transportation and per diem reimbursements for authorized expenses in accordance with federal travel regulations.
- All candidates MUST be willing to travel up to, but not limited to 320 plus days a year during the term of this
 appointment unless leave is authorized.
