Description

The City of Fishers is seeking an Inspector - Water Quality. This Inspector position in the Water Quality Division performs review and inspection of commercial and residential properties, and city stormwater and wastewater infrastructure, for compliance with the city's Stormwater and Wastewater Utilities' Ordinances and administrative policies, MS4 Permit, along with applicable Local, State and Federal requirements. Work is performed under the direct supervision of the Stormwater Engineer and Assistant Director or their designee.

Examples of Duties

- Performs stormwater infrastructure, drainage, construction site stormwater pollution prevention plan, drainage easement permit, and floodplain inspections and reporting under the City's ordinances, MS4 permit, and National Flood Insurance Program (NFIP) participation
- Performs inspections and permit review under the City's Fats, Oils and Grease Management Program
- Performs inspections for the City's Sump Pump Disconnection Program
- Performs routine inspections and reporting of City owned stormwater and wastewater conveyance infrastructure, including Stormwater Best Management Practice (BMP) facilities, ponds, inlets, piping, manholes, cleanouts, etc.
- Performs water quality and illegal dumping sampling, investigation, and reporting
- Reviews construction plans, permit conditions, and operations and maintenance manuals for compliance with City's stormwater and wastewater requirements
- Enters inspection data into the City's computerized inspection and facility maintenance management systems
- Assists in preparation of reports and other documentation necessary for compliance with applicable Local, State and Federal requirements
- Responsible for enforcing infrastructure, drainage, BMP, drainage and sanitary sewer easement, floodplain, and illegal dumping code requirements by issuing fines/violations until issues are resolved
- Performs other related duties as assigned including but not limited to special event attendance such as recycling days, waterway cleanups, and other public education related events

Minimum Qualifications

- Possess certification in stormwater facility inspection, construction inspection, collection system operation and maintenance or related areas of expertise, or be able to obtain within 12 months;
- HS Diploma or equivalent required; Associate degree in water management, environmental science, engineering or related field highly desirable;

- Valid driver's license and ability to be insured to drive a city vehicle required which includes as least 3 years as a licensed driver;
- Able to read and understand architectural and engineering drawings;
- Able to communicate with a variety of people verbally and in writing;
- Able to interact effectively with others in sometimes difficult situations;
- Able to lift and carry objects up to 50lbs.;
- Able to climb ladders, crawl, and move in confined spaces;
- Able to handle several projects at the same time;
- This position requires some evening, weekend, and on-call related after-hours work.
