Silver Jackets

Many Agencies, One Solution!

The Silver Jackets is an innovative program that provides an opportunity to consistently bring together multiple state, federal, and sometimes tribal and local agencies to learn from one another and apply their knowledge to reduce risk.

State agencies, including those of the State Hazard Mitigation Officer and State NFIP Coordinator, come together with the Federal family of agencies, including the U.S. Army Corps of Engineers and the Federal Emergency Management Agency, in a common forum to address the state's flood risk management priorities. Silver Jacket programs are developed at the state level — there are currently 39 active state teams with the ultimate goal of offering an interagency team in every state.

The program's primary goals are to:

- Create or supplement a mechanism to collaboratively identify, prioritize, and address



risk management issues and implement solutions;

- Increase and improve risk communication through a unified interagency effort;
- Leverage information and resources and provide access to such national programs as FEMA's Risk Mapping, Assessment, and Planning (Risk MAP) program and USACE's Levee Inventory and Assessment Initiative;
- Provide focused, coordinated hazard mitigation assistance in implementing high priority actions such as those identified by state mitigation plans; and
- Identify gaps among agency programs and/or barriers to implementation, such as conflicting agency policies or authorities, and provide recom-

mendations for addressing these issues.

The program's desired outcomes are:

- Reduce flood risk;
- Agencies better understand and leverage each others programs;
- Collaboration between various agencies, coordinated programs, and cohesive solutions;
- Multi-agency technical resource for state and local agencies; and
- Mechanism for establishing relationships to facilitate integrated solutions post-disaster.
